- Horses that kick MUST have red ribbons in the tail. Red ribbon will be available at Secretary's booth
- No stallions permitted on property

PLACINGS: Ribbons will be awarded for 1st-6th. Jump only rounds judged on penalty points. All clear rounds awarded 1st. Awards for Day's

End High Point and Reserve Champion for combined training and dressage scores.

ARMBANDS: Armbands are not required but are recommended

**VESTS:** Vests are not required but recommended for all stadium jumping. Required for any cross country schooling

WATER: Is available on grounds.

ARENA: All tests will be ridden in an indoor, small size dressage arena
